 - Sparwood Library (a KLF Library) is closed temporarily and without staff on-site. This is impacting the community and other libraries in the area. The Public Libraries Branch is in contact with the Library Board, is monitoring the situation, and is providing guidance. The absence of a library director means the library cannot run right now. This is a reality that

smaller libraries should be aware of, as it is hard to recruit Librarians to smaller communities. Because of the closure, Interlibrary loan services to and from Sparwood through Sitka (Interlibrary Connect) and Illume have been turned off during this period.

Recently, the Castlegar library struggled to hire a new librarian. In the end, they hired a Library
 Tech with many years of experience at that library

Budget Committee – Pat
